- Accountability to principles of successful and inclusive implementation of the CC funding <u>Bill C35</u> - <u>National Advisory Council</u> oversight - standards and long term funding and implementation recommendations.
 - To include important Provincial & Municipal factors to ensure voices of underrepresented women, newcomers, racialized and gender diverse groups etc. (acknowledge that access and inclusion strategies need to be applied to non-profit and for-profit child care, careful attention to
 - engaging and managing the for-profit CC sector as many communities require for profit services providers to fill gaps in community needs. Building back in financial accountability for large

corporate CC and to ensure inclusion of diverse needs and workplace standards including, wages, training and development of Early Learning Professionals meet the established standards. Particularly real for large centres where for-profit CC is the only option.
